Short Title These Regulations may be cited as the "Determination of land Ren- tals for Mining Operations Regulations No. 15/1999"</p> <p>2. Definitions In these Regulations, the terms "mining operations", "to mine", "licence", "toprospect", "ex- ploration", "artisanal mining", "precious mineral", and "small scale mining" shall have the de- finitions given to them in the Mining Proclamation No. 52/ 1993.</p> <p>3. Payment of land Rental The licensee shall pay in accor- dance with these Regulations an- nually in advance a land rent for the licence area.</p>

- 4. **HAMMA KIRAA LAFAA**
Abbaan hayyamaa kam iyyuu lafa km² tokko ykn km² tokkoo gadi bakka hayyamaan qabateef waggaatti kiraan lafaa inni kaffalu akka kanaan gaditti argamuu dha:
1. Abbaan heyyama barbaachaa qar. 40
2. Abbaan heyyama qorannoo qar. 60
3. abbaan heyyama hojii hoomisha albuudaa karaa aadaa:
a) Albuudaawwan kabajamoof qar. 100
b) Albuudaawwan biroof qar. 50
- 5. **WAA'EE WALITTI-QABUU KIRAALAFAA**
Biroom, Misooma qabeenya Bishaan, Albuudaa fi Inarjii Oromiyaa hojiiwwan albuudaa hundaa irratti bu'ura Dambii kanaatiin kiraalafaa ni kaffalchiisa/sassaaba.
- 6. **YEROO KAFFALTII DABARSUU**
Kaffaltiin kam iyyuu akka Dambii kanaan raawwatamuun irra jiru osoo hin raawwatamiin yoo hafe, mallaqni hin kaffalamiin ture ji'aaf ykn yeroo ji'a tokkoo gadi ta'eef ababa %2itti dabalee kaffala. Adabbiiin dhiibbantaa 50 (50%) yoo caalee heyyamni irraa haaqamee tarkaanfiin seeraa ni fudhatama.
- 7. **NAGA'EE**
Abbaan heyyamaa hundi kiraa kaffaleef Abbaa Taayitaa gibiraa kiraa lafaa irraa fuudherra naga'een seera-qabeessi ni kennamaaf.
- 8. **TUUMAATOOTA CEE'UMSAA**
1. Kiraan lafa kanaan dura hojii albuudaaf kenname kan ragga'ee turu hanga Dambiin kun hojirra oolu jalqabetti qofa.
2. Kiraan lafaa yoo heyyama kessatti hin ibsamne ta'e, kiraan lafaa haala Dambii kana kessatti ibsametti kan raawwatamu ni ta'aa.

- ፮. ኪራይ ስለማስከፈል የአርማያ ውሃ የማዕደንና አነርጂ ሀብት ልማት ቢሮ በዚህ ደንብ መሠረት በማዕደን ሥራዎች ላይ የመሬት ኪራይ ያስከፍላል የሥነ ስላሳ ስላሳ ።
- ፯. ከፍቶ ስለማዘገየት ማንኛውም ባለፈቃድ በዚህ ደንብ መሠረት መረጃም ያለበትን ከፍቶ በወቅቱ ካልረጸመ ለዘገየበት ለእያንዳንዱ ወር ወይም ከወር ላነሰ ጊዜ 2% መቀጫ ጥምር ይከፍላል ። መቀጫው ከሃምሳ ፐርሰንት በላይ ከሆነ ፈቃዱ ተሠርቦ ሕጋዊ እርምጃ ይወሰዳል ።
- ፯. ስለደረሰኝ ማንኛውም ባለፈቃድ ለፈቃድ ሰጪው ባለሥልጣን ለከፈለው የመሬት ኪራይ ሕጋዊ ደረሰኝ ይሰጠዋል ።
- ፰. የመሸጋገሪያ ደንጋጊዎች
፩. ከዚህ ቀደም ለማዕደን ሥራ የተሰጠ መሬት ኪራይ ልክ ጸንቶ የሚቆየው ይህ ደንብ እስከ ጸደቀበት ጊዜ ብቻ ይሆናል ።
፪. የመሬት ኪራይ ካልተጠቀሰ በዚህ ደንብ የተመለከተው የመሬት ኪራይ ተረጋግጦ ይሆናል ።

- 4. **Amount of Rentals**
The annual rentals to be paid by a licensee for each square kilometer of the licence area or any part thereof shall be as follows:
1. The holder of a prospecting licence.....Birr 40
2. The holder of an exploration licenceBirr 60
3. The holder of an artisanal mining licence
a) For precious mineralsBirr 100
b) For other mineralsBirr 50
4. The holder of a small scale Mining Licence
a) For precious mineralsBirr200
b) For other MineralsBirr 150
5. The holder of large scale mining licence
a) For precious mineralsBirr 600
b) For other mineralsBirr 500
- 5. **Collecting Rentals**
In accordance with these Regulations, the Water, Mineral and Energy Resources Development Bureau of Oromia shall collect rentals on mining operations.
- 6. **Overdues**
Any amount payable in accordance with these Regulations, which is not paid in due time, shall be subject to a fine of 2% for each month or part thereof. When the fine is more than 50%, the licence shall be revoked and legal measures be taken.
- 7. **Receipt**
The licensee shall be given a receipt by the licensing Authority for the land rental payments.
- 8. **Transitory Provisions**
1. Rental rate for land granted prior to the issuance of these Regulations shall be valid until the effective date of these Regulations.
2. Where the rate of rent is not specified, the rate provided for in these Regulations shall apply.
