 ፪. **ትርጓሜ**
 በዚህ ደንብ ውስጥ፡-
 ፩. “ምልክት” ማለት ገዳዩ በሚመለከተው አካል የተፈቀደ የንግድ ምልክት ነው።
 ፪. “የንግድ ሥራ” ማለት በንግድ ሕግ አንቀጽ ፮ ሥር የተገለፀ ሥራዎች ወይም በሌላ ሕግ የንግድ ሥራዎች የተባሉ ናቸው።

Regulations To Provide For Rural Land Use Fee On Advertising Boards
 These Regulations are issued by the Executive Committee of the Oromia Regional State pursuant to Article 54(6) of the Constitution of the Region.
 1. **Short Title**
 These Regulations may be cited as the “Rural land Use Fee on Advertising Boards No. 17/2000.”
 2. **Definitions**
 In these Regulations:
 1) “Trade Mark” means a trade mark, given by a concerned authority.
 2) “Commercial activity” means activities carried on by a business person as specified under Article 5 of the Commercial Code or those assumed as commercial activities under other laws.

- 3) "Dhaabbata" jechuun hojii daldalaa ykn hojii biraa kamiyyuu gaggeessuuf qaama seerummaa qabuudha; kunis daldalaa dhuunfaa ni dabalata.
- 4) "Magaalaa" jechuun magaalaa bulchiinsa magaalaa qabu ykn seeraan qaamni magaalummaa kan kenneef jechuudha.
- 5) "Taappeellaa Beeksisaa" jechuun dhaabbanni maqaa ykn hojii ykn hoomisha ykn tajaajila isaa beeksisuuf magaalaa alatti kan maxxansu ykn dhaabu jechuudha.

3. Aangoo fi Hojii Bulchiinsa Aanaa

- 1) Dhaabbanni kamiyyuu taappeellaa beeksisaa dhaabuuf yammuu gaafatu: Bulchiinsi Aanaa:
 - (a) Lafti taappeellaan irratti dhaabbatu lafa hojii biraatiif hin oolle ta'uu isaa ni mirkaneessa;
 - (b) Dhaabbanni taappeellaa beeksisaa dhaabuuf gaaffi dhi'esse heyyama daldalaa fi aasxaa seeraan beekamu qabaachu isaa ni mirkaneessa;
 - (c) Iddoon taappeellaan beeksisaa itti dhaabbatu sochii uummataa ykn hojii nama biraa irratti rakkoo kan hin uumne ta'uu isaa mirkaneessee ni heyyama.

2. Bulchiinsi Aanaa:

- (a) Foormii waliigaltee Biir-oon Faayinaansii baasu irratti hundaa'ee dhaabbata taappeellaa dhaabu wajjin waliigaltee mallatteessuudhaan koppii waliigaltichaa yeroo gababaa keessatti Waajjira Faayinaansii Aanaatiif ni dabarsa;
- (b) Kiraa haala Dambii kanaan kafalamuu qabu dhaabbatni kamiyyuu yoo kaffaluu baate taappeellaa isaa akka kaasuu ni taasisa;
- (c) Taappeellaan armaan dura dhaabbatee ture dirqama Dambii kana keessatti ibsame akka guutu ni godha;
- (d) Raawwannaa Dambii kanaa ilaalchisee yeroo yeroodhaan Bulchiinsa Godinaatiif gabaasa ni dhiyeessa.

፫. "ድርጅት" ማለት ግንኙነት ላይ የተገኘ ሥራ ወይም ሌላ ሥራ ለመስራት መብት የተሰጠው አካል ነው። ይህም ግለሰብ ነጋዴን ይጨምራል።

፬. "ከተማ" ማለት የከተማ አስተዳደር ያለው ወይም የከተማነት ሕጋዊ መብት የተሰጠው ከተማ ማለት ነው።

፭. "የማስታወቂያ ሠሌዳ" ማለት አንድ ድርጅት ስሙን ወይም ሥራውን ወይም ምርቱን ወይም አገልግሎቱን ለማስተዋወቅ ከከተማ ክልል ውጭ የሚላ ጥረት ወይም የሚያቆመው ማለት ነው።

፫. የወረዳ መስተዳድር ሥልጣንና ተግባር

፩. ግንኙነት ድርጅት የማስታወቂያ ሠሌዳ ለማቆም የወረዳ መስተዳድርን ከጠየቀ መብት ዳድሩ።

ሀ) የማስታወቂያ ሠሌዳው የሚቀምጠው መሬት ለሌላ ሥራ የማይውል መሆኑን ያረጋግጣል።

ለ) የማስታወቂያ ሠሌዳውን ለማቆም የጠየቀው ድርጅት የገንደ ፈቃድና ሕጋዊ ዕውቅና የተሰጠው ምልክት እንዳለው ያረጋግጣል።

ሐ) የማስታወቂያ ሠሌዳው የሚቀምጠው ስታብሊሽን እንቅስቃሴ ወይም ስሌት ሰው ሥራ ላይ ትግር የማይፈጥር መሆኑን አረጋግጦ ይፈቅዳል።

፪. የወረዳው መስተዳድር፦

ሀ) የአርማያ ፍይናንስ ቢሮ በማያጠባው ፎርም መሠረት የማስታወቂያ ሠሌዳ ከሚያቆመው ድርጅት ጋር ውል በመፈራረም የውሉን አንድ ቅጂ በአዋርጊዜ ውስጥ ለወረዳው ፍይናንስ ጽ/ቤት ያስተላልፋል።

ለ) በዚህ ደንብ መሠረት መክፈል የሚገባው ኪራይ ያልከፈለ ግንኙነት ድርጅት የማስታወቂያ ሠሌዳውን እንዲያነሳ ያደርጋል።

ሐ) ከዚህ በፊት ተተክሎ የነበረ የማስታወቂያ ሠሌዳ በዚህ ደንብ ውስጥ የተገለጸውን ግዴታ እንዲያግኝ ያደርጋል።

መ) የዚህን ደንብ አፈጻጸም አስመልክቶ በየዚህው ለሆኑ መስተዳድር ሪፖርት ያቀርባል።

3) "Organization" means any person authorized to carry on commercial activity or another activity; this includes sole business person.

4) "Urban" Means any town which has an urban administration or a legal entity.

5) "Advertising Board" means a board posted or erected in rural areas by an organization to make public its name or work or product or services.

3. Powers and Duties of the Wereda Administration

1) When an organization applies to post or erect an advertising board, the Wereda Administration shall ascertain that the:

- (a) land requested for this purpose is not used for another activity;
- (b) organization has a lawful license and trade mark;
- (c) land identified for this purpose does not create a traffic jam or an obstacle on the activity of another person.

2) The Wereda Administration may:

- (a) sign an agreement with the Organization, in the agreement form issued by the Finance Bureau, and send its copy to the Wereda Finance Office forthwith;
- (b) compel an Organization to demolish or remove its advertising board if it doesn't pay the land use fee provided for in these Regulations;
- (c) require an Organization which posted or erected advertising board before the effective date of these regulations to comply with it.
- (d) report the implementation of these Regulations to the Zonal Administration.

4. Aangoo fi Hojii Waajjira Faaynaansii Aanaa

- Waajjirri Faaynaansii Aanaa:
- 1) Waliigaltee mallattaa'e irratti hundaa'uudhaan kiraa Dambii kana keessatti murtaa'e ni kafalchiisa;
- 2) Kiraan waggaa waggaadhaan yeroo murtaa'e keessatti yoo hin kafalamne taapeellaan beeksisaa akka ka'us Bulchiinsa Aanaa wajjin ta'uudhaan tarkaanfii barbaachiisaa ta'e ni fudhata.

5. Hamma Kiraa Kaffalamuu

- 1) Magaalaa alatti Taappeellaa Beeksisaa dhaabbatu irratti akkaataa Labsii Naannoo Oromiyaatti haala Ittifayyadama Lafa Baadiyyaa Hojii Investimantiif ta'u Murteessuuf bahe Lakk. 3/87 irratti Godinaaleef sadarkaa kennameen, beeksisaa fuula tokkoon barreeffamu yoo ta'e, ballina taappeellaa kaare meetira tokkoof waggaa tti:
- (a) Godinaalee sadarkaa tokkoffaa keessatti argamaniif qr. 50.00 (shantama);
- (b) Godinaalee sadarkaa lamaffaa keessatti argamaniif ... qr. 30.00 (soddoma);
- (c) Godinaalee sadarkaa sadaffaa keessatti argamaniif qr. 15.00 (kudha shan); ni kafalama.
- 2) Ballina taappeellaa kaare meetira tokkoo gadi ykn ol ta'e, akkasumas taappeellaa fuula lachuuttuu barreeffame irratti haalumataarifa keewwata kana keewwata xiqqa (1) jalatti ibsameen shalagamee kiraan ni kafalama.

6. Yeroo kiraan Itti kafalamu

- 1) Dhaabbatni taappeellaa beeksisaa akka dhaabbatu heyyamameef kamiyyuu kiraa waggaa sanii yeroodhuma sana ni kafala.
- 2) Kiraan waaggoota itti aananii waggaa waggaadhaan Adoolessa 1 irraa kaasee hanga Onkoloolessa 30 tti ni kaftalama.

፬. የወረዳ ፋይናንስ ጽ/ቤት ሥልጣንና ተግባር

የወረዳ ፋይናንስ ጽ/ቤት፡-

- ፩. በተፈረመው ውልቅ መሠረት በዚህ ደንብ የተወሰነውን ኪራይ ያስከፍላል፤
- ፪. ኪራዩ በየዓመቱ በተወሰነው ጊዜ ውስጥ ካልተከፈለ ከወረዳው መስተዳድር ጋር በመሆን የማስታወቂያ ሠሌዳው እንዲነሣም አስፈላጊውን እርምጃ ይወስናል።

፭. የኪራይ መጠን

፩. ከከተማ ክልል ውጭ በሚቆም የማስታወቂያ ሠሌዳ ላይ በአጭረ ሜትር ክልል ለአንገሰት መንገት ተግባር የሚውል የገጠር መሬት አጠቃቀምን ለመወን በወጣው አዋጅ ቁጥር 1/1995 ለዞኖች በተሰጠው ደረጃ መሠረት በአንድ ገንብ ስም በተጻፈው ማስታወቂያ በአንድ ካሬ ሜትር ስፋት በዓመት፡-

- ሀ) በአንድኛ ደረጃ በሚገኙ ዞኖች በዓመት ብር ፶ (ሃምሳ ብር)፤
- ለ) በሁለተኛ ደረጃ በሚገኙ ዞኖች በዓመት ብር ፴ (ሁላሳ ብር)፤
- ሐ) በአንድኛ ደረጃ በሚገኙ ዞኖች በዓመት ብር ፲፮ (አሥራ አምስት ብር) ይከፈላል።

፪. ከአንድ ካሬ ሜትር በታች ወይም በላይ ስፋት ባለው እንዲሁም በሁለተኛ ገኖች የተጻፈበት ሠሌዳ ከሆነ በዚህ አንቀጽ ንዑስ አንቀጽ (፩) ውስጥ በተገለጸው መሠረት ተሰልፎ ኪራዩ ይከፈላል።

፮. ኪራዩ የሚከፈለበት ጊዜ

- ፩. የማስታወቂያ ሰሌዳ እንደያቆም የተፈቀደለት ማንኛውም ድርጅት የዓመቱን ኪራይ ወዲያውኑ ይከፍላል።
- ፪. የሚቀጥሉት ዓመታት ኪራይ በየዓመቱ ከሐምሌ ፩ ቀን እስከ ጥቅምት ፴ ድረስ መከፈል አለበት።

4. Powers and Duties of the Wereda Finance Office

The Wereda Finance Office shall:

- 1) collect the land use fee provided for in these Regulations in accordance with the agreement signed;
- 2) in collaboration with the wereda administrative office, take necessary action to demolish or remove the advertising board if the land use fee is not paid each year within the fixed time.

5. The Amount Of The Land Use Fee

1) Advertising board posted or erected in rural land shall pay fees, in accordance with the standards given to zones under the proclamation issued to provide for the Utilization of rural land for Investment Activities in the Oromia Region.

No.3/1995, for an advertisement written in one side of the board. The tariff per m² shall be as follows:

- (a) In the first grade Zones.... Birr 50.00
- (b) In the third grad zones..... Birr 30.00
- (c) In the third grad zones..... Birr 15.00

2) Where the size of the board is less or greater than one m² and/ro the advertisement is written in both sides, the amount of the fee shall be assessed according to the tariff specified under sub-article (1) of this Article.

6. Time of Payment

- 1) Any organization permitted to post or erect an advertising board shall pay the land use fee of the year forthwith.
- 2) The Land use fee of the next years shall be paid from the Month of July to October each year.

- 3) Dhaabbatni otuu Dambiin Kun hin bahiin dura taappeellaa Naannoo Oromiyaa keessatti dhaabee jirus guyyaa Dambiin kun ragga'ee kaasee haala Dambii kanaatiin kiraa ni kafal.
- 7. **Kafaltii kiraa irraa bilisa ta'uu**
Dhaabbatni:
 - 1) Hojii daldalaaf dhaabate mooraa isaa keessatti ykn waajjira isaarratti taappeellaa fannise ykn maxxanise ykn
 - 2) hojii daldalaa tiif hin hundeffamne kiraa haala Dambii kanaan kafalamu irra bilisa ni ta'a.
- 8. **Aangoo Qajeelfama Baasuu**
Biiroon Faaynaansii Oromiyaa Dambii kana hojiirra oolchuuf qajeelfama barbaachisaa ta'e baasuuf aangoo ni qabaata.
- 9. **Adabbii**
Dambii kana ykn Dambii kana irratti hundaa'e qajeelfama bahe dhaabbatni cabse kamiyyuu Seera Adaba Yakkaaatiin ni adabama.
- 10. **Dambii raawwattiinsa Hin-Qabne**
Dambiin ykn qajeelfamni yin haalli hojii Dambii kanaan wal-faallëssu kamiyyuu dhimmoota Dambii kana keessatti ibsaman irratti raawwattiinsa hin-qabaatu.
- 11. **Yeroo Dambiin Kun Itti Ragga'u**
Dambiin kun Sadaasa 01 bara 1993 irraa eegalee hojiirra ni oola.

፱. ቅጣት

ይህንን ደንብ ወይም በዚህ ደንብ ላይ ተመሥርቶ የወጣውን መመሪያ የጣሰ ማንኛውም ድርጅት በወንጀል መቅጫ ሕግ መሠረት ይቀጣል።

፲. ተፈጻሚነት ስለማይኖረው ደንብ

ይህንን ደንብ የሚቃረን ማንኛውም ደንብ ወይም መመሪያ ወይም የአሠራር ሁኔታ በዚህ ደንብ ውስጥ በተመለከተ ጉዳዮች ላይ ተፈጻሚነት አይኖረውም።

፲፩. ደንቡ የሚጸናበት ጊዜ

ይህ ደንብ ከህዳር ፩ ቀን ፲፱፻፺፫ ዓ.ም ጀምሮ የፀና ይሆናል።

3) An Organization which posted or erected an advertising board in the Oromia Region prior to the enactment of these Regulations shall pay the land use fee provided for in these Regulations from the effective date of these Regulations.

7. Exemption

- Any organization which:
- 1) erected or posted its Advertising board in its compound or on its building, or
 - 2) is not established to carry on a commercial activity shall not pay land use fee.

8. Power To Issue Directives

The Oromia Finance Bureau shall have a power to issue directives for the proper implementation of these Regulations.

9. Penalties

Any organization which violates these Regulations or directives issued to implement these Regulations shall be punishable in accordance with the Penal Code.

10. Inapplicable Laws

Any Regulations, or directives or decisions inconsistent with these Regulations shall not be applicable with respect to matters provided for in these Regulations.

11. Effective Date

These Regulations shall come into force as of the 10th day of November, 2000.
