REGULATIONS TO PROVIDE FOR  
SERVICE TAXES ON REVENUE  
FROM HARVESTING MACHINE  
SERVICES

These Regulations are issued by the Executive Committee of the Oromia Regional State pursuant to Article 54(6) of the Constitutions of the Region.

#### 1. Short Title

These Regulations may be cited as the “Harvesting Machine Service Taxes No. 18/2000.”

#### 2. Service Tax

1. Any owner of a harvesting machine who earns a revenue by hiring machine in the Oromia Region shall pay:

a) Birr 8,750.00 service tax each year per the machine at flat rate;

- b) Gibirri bu'aa daldalaas galii wagga taaksii kana murteessuuf bu'uura ta'e kana irratti heregamee ni kafalama.
2. Taaksiin Dambii kanaan murtaa'e barbaachisaa ta'ee yoo argame wagga sadisadiin Biirroo Faaynaansii jijiiramu ni danda'a.
3. *Yeroo Taaksiin Kun Itti Kafalamu*  
Taaksiin gurgura tajaajilaa walakkaan (qarshiin 4375.00) otuu kombaayneerri kamiyyuu hojiitti hin bobbain yaadannoodhan kan kafalamu ta'ee, kan hafe immoo hanga ji'a Guraandhalaa bara sanaatti kafalamuu qaba.
4. *Bakka Taaksiin Kun Itti Kafalamu*  
Taaksiin kun Biirroo Faaynaansii Oromiyaatti kafalama.
5. *Wa'ee To'anno*
1. Biirroon Geejibaa fi Quunnamtii Oromiyaa kombaayneeraaf:
    - a) Lakkoofsa gabatee ni kenna; wagga wagga adhaanis kalaawudoo ni godha;
    - b) Bara baraan otuu kalaawudoo hin godhiniif dura taaksii fi gibirri irraa barbaadamu kafalamuu isaatiif waraqaan qulqullummaa Biirroo Faaynaansii Oromiyaa irraa abbaa qabeyynaatiin akka dhiyatatu ni godha.
  2. Poolisiin Kombaayneerrikam iyyuu lakkoofsa gabatee otuu hin maxanfatin ykn bara baraan kalaawudoo otuu hin godhatiin karaarra akka hin sochoone ni too'ata.
  3. Abbaan qabeenya kombaayneeraa kam iyyuu Biirroo Daldala, Industrii fi Tuurizimiitti galmeeffamee heyyama hojii fi daldala baafchuu qaba.
  4. Biirroom Faaynaansii Oromiyaa gibiraa fi taaksii Dambii kanaan murtaa'e kafalchiisee waraqaa qulqullummaa qaama dhimmiilaaluuf ni barreessaaf.

- b) profit tax assessed on the basis of revenue that generates the tax.
2. *The amount of the service tax* fixed by these Regulations may be modified by the Oromia Finance Bureau with an interval of three years, where it is necessary.
3. *Time of Payment*  
Half of the service tax (Birr 4,375.00) shall be paid in advance before commencing the service and the remained half shall be paid up-to the month of February of the same year.
4. *Place of Payment*  
The tax shall be paid at the Head Office of Oromia Finance Bureau.
5. *Control*
1. The Oromia Transport and Commissions Bureau shall:
    - a) issue plate number for each harvesting machine and examine the machine annually;
    - b) order the owner of the machine to produce a clearance paper from the Oromia Finance Bureau before examining the machine.
  2. A police shall take action on a harvesting machine which does not have a plate number or doesn't make annual examination.
  3. Any owner of a harvesting machine shall be required to obtain a valid working license from the Oromia Trade, Industry and Tourism Bureau.
  4. The Oromia Finance Bureau shall collect the tax fixed by these Regulations and give a clearance paper.

6. *Aangoo Qajeelfama Baasuu*  
Biiroon Faaynaansii Oromiyyaa Dambii kana hojiirra oolchuuuf qajeelfama barbaachisaa ta'e baasuuf aangoo ni qabaata.
7. *Wa'ee Adabbii*  
Seerrii adabbii kana caalaa adabsiisu yoo jiraate malee, abbaan qabeenyaa:  
 a) Waraqaa qulqullummaa osoo hin qabaatiin ykn,  
 b) Lakkoofsa gabatee ykn kalaawudoo osoo hin maxfatiin ykn;  
 c) Heyyama hojii daldalaa osoo hin baafatiin ykn hin haarofsfatiin hojii irratti bobba'ee yoo argame Seera Adaba Yakkaatiin ni adabama.
8. *DAmbii Raawwatiinsa Hin Qabne*  
Dambii kana faallessu Dambii ykn qajeelfamni ykn haalli hojii kamiyyuu dhimmoota Dambii kan keessatti ibsamman irratti raawwatiinsa hin qabaatu.
9. *Yeroo Dambiin Kun Itti Ragga'u*  
Dambiin kun Onkolooleessa 6 bara 1993 irraa eegalee kan ragga'e ta'a.

6. *Power to Issue Directives*  
The Oromia Finance Bureau shall have a power to issue directives for the proper implementation of these Regulations.

#### 7. *Penalties*

- Unless punishable with more sever penalty under other law, an owner of a harvesting machine who commences work without:  
 a) having a clearance paper or  
 b) making a plate number and annual examination or  
 c) having a valid business license or renewing same shall be punishable in accordance with the relevant provisions of the Penal Code.

#### 8. *Inapplicable Laws*

Any Regulations, directives, or practices inconsistent with these Regulations shall not be applicable with respect to matters provided for these Regualations.

#### 9. *Effective Date*

These Regulations shall enter into force as of the 16<sup>th</sup> day of October, 2000.
