**፩. “ቢሮ”** ማለት የአሮሚያ ትራንስፖርትና መገናኛ ቢሮ ነው።

**፪. “ውድድር”** ማለት እያንዳንዱ ማሕበር ወይም ድርጅት በአንድ የስምረት መሥመር ላይ በክብ ካቢ ወይም ዋጋ በመቀነስ መንገደኞችን ለማጓጓዝ የሚያደርገው ውድድር ማለት ነው።

**PUBLIC ROAD TRANSPORT REGULATIONS**  
 These Regulations are issued by the Executive Committee of the Oromia Regional State pursuant to Article 54(6) of the Constitution of the Regional State of Oromia.

- Short Title**  
 These Regulations may be cited as the “Public Road Transport Regulations No. 19/2000.”
- Definition**  
 Unless the context otherwise requires, in these Regulations:
  - “Bureau” means Bureau of Oromia Road Transport and Communications.
  - “Competition” means a contest to be made on line of operation by an association or enterprise to transport passengers with care or reduced fare.



- 3) "Jaarmiyaa" jechuun kan-kolaattota qabeenya dh-uunfaa, ykn Mootummaa ykn aksiyoonii ta'an wali-tti qabuudhaan hojii dald-ala geejibaa gaggeessudh-aaf dhaabbata hundaa'e jechuu dha.
  - 4) "Jeequmsa uumuu" jechuun wal-morkiin seeraan akka hin adeemsifamne goolii uumuudhaan konk-olaattota bobbiif ykn dorg-ommiif dhiyaatan akka hin sochoone gochuu ykn namoota gurmeessuudh-aan qabeenya waldoota walddorgomanii fi imaalt-ota isaanii irratti balaa geessisuu ykn sossodaach-isuu ykn gocha kana fakka-aatu biraa raawwachuu jechuu dha.
  - 5) "Sagantaa bobbi" jechuun waldootni ykn jaar-miyootni bakka hojiidhaaf itti ramadaman ykn toora filatan waliin ga'uudhaaf guyyaatti ykn torbanitti ykn guyyaa kudhashaniif ykn ji'aaf imaaltota deddeebisuudhaaf kan baafatan socho'ina hojii isaanii kan ibsu jechuu dha.
  - 6) "Seera" jechuun Seera Hariiroo Hawaasaa ykn seera geejiba karaa ykn kan biraa dhimmaa Dambii kana keessatti ibsame ilaalu jechuu dha.
  - 7) "To'annoo" jechuun seerot-nii fi qajeelfamootni geej-iba karaa sirriitti hojii irra ooluu isaanii mirkane-effachuu jechuu dha.
  - 8) "Waldaa" jechuun waldaa namoota ykn jaar-miyoota hojii daldala geejiba karaa kan ummataa irratti bobba-anii akkaataa Labsii Qaamota Raawwachiiftuu Mootummaa Naannoo Oromiyaa Hundeessuuf Bahe Lakk. 7/1988 keewwata 18(f) tiin galmaa'an jechuu dha.
3. **Daangaa Raawwannaa**  
Dambiin kun waldoota ykn jaar-miyoota haala Dambii kanaatiin Biiroodhaan gurmaa'an irratti raawwatiinsa ni qabaata.
4. **Kaayyoo Fi Hojii Waldootaa**  
Waldaan kamiyyuu:
- 1) Gurmaawanii bakka bob-bii filachuudhaan seeraa fi qajeelfamaa geejibaa eeg-anii tajaajila quubsaa ni kennu;

- ፩. "ድርጅት" ማለት የግለሰብ ወይም የመንግሥት ወይም የእኩ ስዩን የሆኑትን ተሽከርካሪዎችን በግለሰብ የመንገድ ትራንስፖርት ንግድ ለማካሄድ የተቋቋመ ድርጅት ማለት ነው።
- ፪. "ሀብት መፍጠር" ማለት የሥራ ውድድር በሕጋዊ መንገድ እንዳይካሄድ ችግር በመፍጠር ለውድድር ወይም ለስምራት የቀረበ ተሽከርካሪ እንዳይንቀሳቀስ ማድረግ ወይም ግለሰቦችን በማድረግ በተወዳዳሪ ማህበራት ንብረት ወይም መንገደኞች ላይ አደጋ ማድረስ ወይም ማሰፈራራት ወይም ሌላ ተመሳሳይ ድርጊት መፈጸም ማለት ነው።
- ፫. "የስምራት መረሐ ግብር" ማለት ማህበራት ወይም ድርጅቶች ለሥራ የተመደቡ በትን ወይም የመረጡትን መሥመር ለማድረስ ለቀን ወይም ለሳምንት ወይም ለ፲፮ ቀናት ወይም ለ፩ ወር መንገደኞችን ለማመለል የሚያወጡት የሥራ እንቅስቃሴ አገዥ የሚያሳይ ማለት ነው።
- ፬. "ሕግ" ማለት የፍትሐ ብሔር ሕግ ወይም የመንገድ ትራንስፖርት ሕግ ወይም በዚህ ደንብ ውስጥ የተገለጹትን የሚመለከት ሌላ ሕግ ማለት ነው።
- ፭. "ቁጥጥር" ማለት የመንገድ ትራንስፖርት ሕጎችና መመሪያዎች በትክክል ሥራ ላይ መዋላቸውን ማረጋገጥ ማለት ነው።
- ፮. "ማህበር" ማለት በሕዝብ የመንገድ ትራንስፖርት ንግድ ሥራ ላይ ተሰማርተው የአርሚያ ክልላዊ መንግሥት ሥራ አስፈጻሚ አካላትን ለማቋቋም በወጣው አዋጅ ቁጥር ፯/፲፱፻፹፰ አንቀጽ ፲፰ /ረ/ መሠረት የተመዘገቡ ግለሰቦች ወይም ድርጅቶች ማለት ነው።

- ፫. **የተፈጻሚነት ወሰን**  
ይህ ደንብ በዚህ ደንብ መሠረት በቢሮው በተደረጁት ማህበራት ወይም ድርጅቶች ላይ ተፈጻሚ ይሆናል።
- ፬. **የማህበር ዓላማና ተግባር**  
ማንኛውም ማህበር :-
- ፩. ተደራጅቶ የስምራት ቦታ በመምረጥ የትራንስፖርትን ሕግና መመሪያ ጠብቆ አጥጋቢ አገልግሎት ይሰጣል።

- 3) "Enterprise" means an undertaking formed by an individual (sole business person) or government enterprise or share holders that get together their vehicles to run public commercial road transport.
  - 4) "Violence" means an illegal act committed to obstruct a vehicle that comes for operation or competition not to move or cause damage to the property or passengers of a competing association by organizing individuals or to threaten them or to do a similar act.
  - 5) "Operation Program" means a time table fixed by an association or enterprise to cover the area of assignment or choice by transporting passengers daily, weekly, fortnightly or monthly.
  - 6) "Law" means the Civil Code or Road Transport Law or any other law that refers to matters provided for in these Regulations.
  - 7) "Control" means ascertaining the proper implementation of road transport laws and directives.
  - 8) "Association" means an association of individuals or enterprises engaged in public commercial road transport activity and registered in accordance with the Proclamation issued to establish the Executive Organs of the Oromia Regional State No.7/1995 (Art. 18(f)).
3. **Scope of Application**  
These Regulations shall apply to the associations or enterprises established in accordance with these Regulations by the Bureau.
4. **Powers and Duties of Association**  
Any association shall:
- 1) upon getting organized, select area of operation and give efficient transport service by observing transport laws and directives;

- 2) Miseensota isaanii qofaa-dhaaf kan fayyadu kan akka buufata konkolaa-taa waajjiraalee bobpii, bakka suphaa konkolaa-taa, bakka raabsa bob-a'aa, mana meeshaa geed-daraa fi kan kana fakka-atu ni adeemsisu;
- 3) Seerotaa fi qajeelfamoota waa'ee geejiba-karaa ilaal-chisee ba'an miseensotni isaanii akka beekanii fi kabajan ni godhu.

5. *Wa'ee Gurmaayinaa*

- 1) Naannoo Oromiyaa keess-atti namootni dhuunfaa ykn jaar-miyootni hojii gee-jiba-karaa kan ummataa irratti bobba'an waldaa dhaabuu fi miseensa ta'uu ni danda'u.
- 2) Waldaan kam iyyuu nama dhuunfaa ykn jaar-miyaa seera ittiin bulma-ata isaa keessatti kan mul-lifame guuttee argamee fi Naannoo Oromiyaa keess-atti daldala geejiba-umma-taa irratti bobba'e miseen-summaadhaan fudhachu-udhaf dirqama ni qaba.
- 3) Hojii daldala geejiba-karaa kan ummataa irra-tti kan bobba'e namni dhu-unfaa ykn jaar-miyaan kam iyyuu yeroo tokkotti bakka bobpii tokko keessa-tti miseensa waldaa tok-koo ol ta'u hin danda'u.
- 4) Biiroon fakkii ykn modee-hii ittiin bulmaata waldoo-taa baasuu ni danda'a.

6. *Wa'ee Galmeeessuu*

- 1) Waldaan ykn jaar-miyaan gurmaa'e iyyannoo galma-a'uu isaa Dambii ittiin bul-maata isaa waliin qabsii-see Biirootti dhiyeeffac-huu qaba.
- 2) Ennaa iyyannoon galma-a'uu dhiyaatuuf Biiroon Dambii ittiin bulmaata waldichaa ykn jaar-miyic-haa seera kan hin faalles-sine ta'uu isaa mirkanee-see galmaa'uudhaaf kaaff-altii murtaa'ee kaffalchis-uudhaan waldicha ni gal-meessa.

- ፩. ለአባሎቹ ብቻ የሚያገለግል እንደ ተሽከርካሪ መናኸሪያ የመሥራት ጽ/ቤት ጋራ ገዢ ነዳጅ ማደያና የመለዋወጫ ዕቃ ቤት ንፍ የመሳሰሉትን የካሂዳል የመንገድ ትራንስፖርትን በተመለከተ የወጡትን ሕጎችና መመሪያዎች አባሎቹ እንዲያውቁና እንዲያከብሩ ያደርጋል።

፪. በለ ማህበር መደራጀት

- ፩. በእርሚያ ክልል በሕዝብ የመንገድ ትራንስፖርት ሥራ ላይ የተሰማሩት ግለሰቦች ወይም ድርጅቶች ማህበር ለማቋቋም እና አባል ለመሆን ይችላሉ።
- ፪. ማንኛውም ማህበር በመተዳደሪያ ደረጃ ደንቡ ውስጥ የተመለከተውን አሟልቶ የተገኘንና በእርሚያ ክልል ውስጥ በሕዝብ ትራንስፖርት ንግድ ሥራ ላይ የተሰማሩት ግለሰብ ወይም ድርጅት በአባልነት የመቀበል ግዴታ አለበት።
- ፫. በሕዝብ የመንገድ ትራንስፖርት ንግድ ሥራ የተሰማሩ ማንኛውም ግለሰብ ወይም ድርጅት በአንድ ጊዜ በአንድ የሰምሪት መስመር ውስጥ ከአንድ ማህበር በላይ አባል ሊሆን አይችልም።
- ፬. ቢሮው የማህበር መተዳደሪያ ደንብ ናሙና ለማውጣት ይችላል።

፭. በለመመዘንብ

- ፩. የተደራጀ ማህበር ወይም ድርጅት የመመዘንቢያ ማመልከቻውን ከመተዳደሪያ ደንቡ ጋር አያይዞ ለቢሮው ማቅረብ አለበት።
- ፪. የመመዘንቢያ ማመልከቻ ሲቀርብ ለቢሮው የማህበሩ ወይም የድርጅቱ መተዳደሪያ ደንብ ሕግን የማይቃረን መሆኑን አረጋግጦ ለምዝገባ የተወሰነውን ክፍያ አስከፍሎ ማህበሩን ይመዘግባል።

- 2) Construct terminals, operation offices, fuel stations, garages and similar activities for its members only;
- 3) educate its members the laws and directives pertaining to road transport and cause them to observe same.

5. *Establishment of Association*

- 1) Individuals or enterprises engaged in public road transport activities in the Oromia Region may form an association or be a member to an association.
- 2) Any association shall accept an individual or enterprise engaged in public commercial road transport in Oromia Region where it fulfils the requirements specified in its memorandum of association.
- 3) Any individual or enterprise engaged in public commercial road transport may not be a member of more than one association at the same time in one operation line.
- 4) The Bureau may issue a model memorandum of association.

6. *Registration*

- 1) An organized association or enterprise shall submit its application for registration to the Bureau with its memorandum of association.
- 2) Where the application is submitted, the Bureau shall ascertain that the memorandum of association is consistent with the law, and upon the payment of the required fee, register the association.

- 3) Biiroon gaaffii galmaa'uu waldichaa ykn jaarmiyichaa yoo fudhachuu baate sababa isaa ibsuudhaan guyyaa 30 keessatti waldicha ykn jaarmiyicha beeksisuu qaba. Biiroon yeroo jedhame kana keesatti iyyaticha irratti murtee laachuu yoo baate waldichi akka galmaa'etti lakkaawama.
- 4) Waldichi guyyaa galmaa'ee kaasee qaama seerummaa ni argata.

7. Dirqama Waldootaa Yookaan Jaarmiyootaa

- Waldaan ykn jaarmiyaan:
- 1) Waldoota ykn jaarmiyoota biraa bakka bobbii tokko keessa hojjatanii wajjin akka gabaa bilisatti dorgommiidhaan hojjachuu qaba;
  - 2) Maxxantuu waldaa ykn jaarmiyaa biraa ta'ee hojjechuu hin danda'u;
  - 3) Sagantaa bobbii qopheeffachuudhaan guyyaa torba dura Biirootti dhiyeessee mirkaneessiffatee hojii irra oolchuu qaba;
  - 4) Dandeettii qabuun bakkeewwan bobbii filate waliinga'uu qaba;
  - 5) Waldaa ykn jaarmiyaa biraa irratti jeequmsa uumuu hin danda'u;
  - 6) Konkolaataa Biiroodhaan hin galmaa'iin hojjechisuu hin danda'u;
  - 7) Mallattoon to'attoonni isaa ittiin konkolaattota dhaabsisan kan Biiroon itti fayyadamu irraa adda ta'uu qaba;
  - 8) Konkolaataa miseensa isaa hin ta'iin bobbaasuu hin danda'u, haa ta'u malee, sababa humnaa ol ta'een imaaltota deddeebisuu irratti rakkinni yoo uumame Biiroo heeyyamsiisuudhaan bobbaasuu ni danda'a;
  - 9) Konkolaataa hojii irra ooluun hin dandeenye saganntaa keessa galchuu hin qabu;
  - 10) Haala biraatiin Biiroodhaan yoo murtaa'e malee konkolaattota geegiba ummataa galgala saa'atii 12:00 kaasee barrii keesaa hanga saa'atii 12:00 tti bobbasuu hin danda'u;
  - 11) Waraqaa bobbii kennuu kan qabu guyyaa konkolaataan bobba'u qofaa dha;

- ፩. ቢሮው የማሕበሩን ወይም የድርጅቱን የምዝገባ ጥያቄ ላይ ቀበል ከቀረ ያልተቀበለበትን ምክንያት በመግለጽ በ፴ ቀናት ውስጥ ለማሕበሩ ወይም ለድርጅቱ ማሳወቅ አለበት። በተባለው ጊዜ ውስጥ ቢሮው በማመልከቻው ላይ ውሳኔ ካልሰጠ ማሕበሩ እንደተመዘገበ ይቆጠራል።
- ፪. ማሕበሩ ከተመዘገበበት ቀን ጀምሮ የሕግ ሰውነት ያገኛል።

፮. የማሕበር ወይም የድርጅት ግዴታዎች

- ማሕበር ወይም ድርጅት፡-
- ፩. በአንድ የሰምራት ክልል ከሚሠሩ ሌሎች ማሕበራት ወይም ድርጅቶች ጋር በነፃ ገበያ በውድድር መሥራት አለበት።
  - ፪. የሌላ ማሕበር ወይም ድርጅት ግንኙነት መሥራት አይችልም።
  - ፫. የሰምራት መርሐግብር በማዘጋጀት ሥራ ላይ ለማዋል ከ፯ ቀናት በፊት ለቢሮው አቅርቦ አስወዳጅ ተግባራዊ ማድረግ አለበት።
  - ፬. ባለው አቅም የመረጠውን የሰምራት ቦታ ማዳረስ አለበት።
  - ፭. በሌላ ማሕበር ወይም ድርጅት ላይ ሁከት መፍጠር አይችልም።
  - ፮. በቢሮ ያልተመዘገበ ተሽከርካሪን ማሠራት አይችልም።
  - ፯. ተሽከርካሪዎቹን የሚያስቆምበት ምልክት ቢሮው ከሚገለገለበት የተለየ መሆን አለበት።
  - ፰. አባሉ ያልሆነን ተሽከርካሪ ማሠራት አይችልም። ይሁን እንጂ በማያንገዛቸው መንገዶች ላይ ችግር ከደረሰ ቢሮን በማስፈቀድ ሊያሰማራ ይችላል።
  - ፱. በሥራ ላይ ሊውል የማይችል ተሽከርካሪን በሰምራት መርሐግብር ማካተት የለበትም።
  - ፲. በሌላ አኳኝን በቢሮው ካልተወሰነ በስተቀር የሕዝብ ማመላለሻ ተሽከርካሪን ከምሽት 12:00 ሰዓት እስከ-3ጋቱ 12:00 ሰዓት ማሠራት አይችልም።
  - ፲፩. የሰምራት ወረቀት መስጠት ያለበት ተሽከርካሪው በግሰማራበት ቀን ብቻ ነው።

- 3) Where the Bureau refuses to register the association or enterprise, it shall notify the association within thirty days the reason for refusal. Where the Bureau fails to take an action within the specified time, the association shall be assumed registered.
- 4) The association shall have a legal personality from the date of registration.

7. Duties of Association or Enterprise

- An association or enterprise:
- 1) shall work according to the principle of free market by competing with other association or enterprise working in the same area of operation;
  - 2) may not work by being an affiliate to another association or enterprise;
  - 3) shall prepare operation program and submit it to the Bureau before 7 days for approval;
  - 4) shall cover its area of choice for operation with all its capacity;
  - 5) may not create violence on another association or enterprise;
  - 6) may not assign a vehicle that is not registered by the Bureau;
  - 7) shall have a stop sign different from that of the Bureau;
  - 8) may not assign a vehicle which is not its own but when a problem arises in transporting passengers, it can assign the vehicle of another association or enterprise by obtaining prior permission from the Bureau;
  - 9) may not include a vehicle that can not function in an operation program;
  - 10) may not assign public transport vehicles from 6.00 A.M. to 6.00 P.M unless otherwise decided by the Bureau;
  - 11) shall give operation paper only on the date when the vehicle is assigned;

- 12) Gabaasa raawwannaa hojii ji'a sadii sadiittii fi barbaachisaa ta'ee yeroo argamu hundas Biroof dhiyeessuu qaba;
  - 13) Miiensa koree hojii raaw-wachiistuu isaa hojii adeemsisaa gochuu hin danda'u;
  - 14) Heeyyama isaa kan baraa waggaa waggaa adhaan hanga Fulbaana 30 tti haareffachuu qaba;
  - 15) Mallattoo cinaa konkolaa-ttota miseensota isaatiif laachuu qaba;
  - 16) Geejiba ummataa waa'ee mirga imaaltotaa fi kunu-unsaa isaaniif godhamuu qabu hojjetoota isaa balli-naa barsiisuu fi huban-noo qabachiisuu qaba.
8. **Wal-dhabinsa Hiikuu**
- 1) Miseensota waldaa tokkoo gidduutti wal dhabii-nsa umamuuf furmaata kan kennu waldicha ni ta'a.
  - 2) Miseensota waldaa fi hojii geggeessitoota waldichaa ykn waldaa tokkoo fi waldaa biraa gidduutti wal-dhabinsi yoo uumame Biir-oon gidduu seenuudhaan tarkaanfii barbaachisaa ta'e fudhachuu ni danda'a.
9. **Qajeelfama Baasuu**
- Biir-oon Dambii kana hojii irra oolchuudhaaf Qajeelfama baasuu ni danda'a.
10. **Adabbiwwan**
- 1) Waldaan ykn jaar-miyaan kamiyyuu dirqama Dambii kana keewwata 7 keewwata-xiqqaa (1-7) jalatti ibsame yoo raawwachuu baate akka ballessaa cim-aatti lakkaawamee:
    - (a) Balleessaa tokkoffaatiif of-eeggannoo barreffamaa,
    - (b) Balleessaa lammaffaatiif qarshii 1,000.00
    - (c) Balleessaa sadaffaatiif qarshii 3,000.00
    - (d) Balleessaa afurffaatiif qarshii 5,000.00
    - (e) Balleessaa shanffaatiif qarshii 7,000.00
    - (f) Balleessaa jahaffaatiif ha-yyama haquudhaan adab-ama.

- ፲፪. የሥራ አፈጻጸም ሪፖርት በየሦስት ወርና አስፈላጊ ሆኖ በተገኘ ሌላ ጊዜ ለቢሮው ማቅረብ አለበት።
  - ፲፫. የሥራ አስፈጻሚውን አባል ሥራ አስኪያጅ ሊያደርግ አይችልም።
  - ፲፬. የዘመንን (1) የሥራ (1) ፈቃድ በየዓመቱ እስከ መስከረም ወ ማሳደስ አለበት።

8. **Dispute Settlement**
- 1) Where a dispute arises between members of the association, the association may settle it.
  - 2) Where a dispute arises between members of the association and its executive committee or between one association and another association, the Bureau may interfere and take necessary measure.
9. **Issuance of Directives**
- The Bureau may issue directives to implement these Regulations:
10. **Penalties**
- 1) Failure to fulfill the duty specified under Art.7(1-7) shall constitute a serious fault and the association or enterprise shall be penalized the following:
    - (a) for first offence, written warning,
    - (b) for second offence, Birr 1000.00,
    - (c) for third offence, Birr 3000.00,
    - (d) for fourth offence, Birr 5000.00,
    - (e) for fifth offence, Birr 7000.00,
    - (f) for sixth offence, revocation of license.

- 2) Failure to fulfill the duty specified under Art.7(8-15) by an association or enterprise shall constitute a petty offence and the association or enterprise shall be penalized the following:
    - (a) for first offence, oral warning,
    - (b) for second offence, written warning,
    - (c) for third offence, Birr 500.00,
    - (d) for fourth offence, Birr 1000.00,
    - (e) for fifth offence, Birr 1500.00,
    - (f) for sixth offence, Birr 3000.00,
    - (g) after the 6<sup>th</sup> offence where it commits another petty offence, it shall be penalized Birr 5000.00 for every new offence.
  - 3) The record of the penalty imposed in accordance with the provisions of these Regulations shall remain valid for one year.
  - 4) Revocation of a license of an association or enterprise shall only be made by the Bureau Head.
  - 11. *Inapplicable Regulations*  
Any regulations or directives or decision inconsistent with these Regulations shall not be applicable.
  - 12. *Effective Date*  
These Regulations shall come into force as of their publication in the Megeleta Oromia.
