6. **Power and Duties**
 The institute shall have the following powers and duties
 a) Collect, analyse, publish and distribute information that helps for the preparation of short, medium and long term development directions.
 b) Conduct on its own or by others development related researchs and study that enhance accelerated and sustainable development, distribute the output of research and study to the concerned executives.
 c) Conduct studies on its own or by others, that could be submitted for organizations that enables to obtain financial and technical support.
 d) Provide completed researches and study works to the Regional Government and concerned institutions.
 e) Conduct study, on its own or by others, projects over which the Regional Government should intervene in accordance with the investment policy, law and regulations.
 f) In cooperation with international, regional and local development organizations, develop the capacity in terms of attaining sufficient trained manpower necessary to conduct development research and study.
 g) Perform such other activities as may be necessary for the attainment of its objectives.

7. **Organs of the Institute**
 The institute shall have:
 1) A Director and
 2) The necessary staff

8. **Powers and Duties of the Director**
 1) The Director shall be the executive officer and shall control and administer all activities of the Institute.
 2) Implement and follow up the objectives, powers and duties of the institute specified in these Regulations.

 (e) Akkaataa imaammata, seeraa fi gajeelfama investimeentiifin projekti mootummaan naamichaa irratti hirmaacuu danda'u ni gorata akka goratamanis ni taasisa.
 (f) Qorannaa fi qo'annaa misoomaatiin humna nama baratee maatiin humna nama baratee gahaa ta'e horachuuf dhaabbilee misoomaa addunyaa, ardiif biyya keessaa wajjin waliin ta'uun gormanaa fi qo'annaan misoomaa akka babal'atu ni godha.
