

Short Title This Proclamation may be cited as the “1990 Fiscal year Oromia Regional State Budget Proclamation No.24/1998”.</p> <p>2. Budget year and Amount of Budget A Regional Budget is hereby appropriated for the fiscal year commencing on Hamle 1,1990 E.C. from public revenues and other funds for the purposes and services set forth in the schedule hereto:</p>

- ፩. ጉዳዩ የሚመለከታቸው የኦሮሚያ ክልላዊ መንግሥት አካላት የበላይ ኃላፊዎች ለየመሥሪያ ቤታቸው ሥራና አገልግሎት ከክልሉ ገቢ እና ከሌላ ገንዘብ በዚህ አዋጅ የተፈቀደ ላቸውን ቦጀት በሚጠይቁበት ጊዜ የኦሮሚያ ፋይናንስ ቢሮ ኃላፊ እንዲከፍል ተፈቅዶለት ታዟል።
- ፪. የተፈቀደላቸው ጠቅላላ የቦጀት መጠን እንደተጠበቀ ሆኖ በኦሮሚያ ክልላዊ መንግሥት ሥር ያሉ ሆስፒታሎች ባለፈው ቦጀት ዓመት ካስገኙት ገቢ 50% (ሃምሳ በመቶ) ሳይበልጥ ከዘመኑ የቦጀት ዓመት ገቢያቸው እንደ አስፈላጊነቱ ወጪ እያደረጉ እንዲሠሩበት ለመፍቀድ ለኦሮሚያ ፋይናንስ ቢሮ ኃላፊ ሥልጣን ተሰጥቶታል።

3. Budget Transfer
Budgetary transfers shall be effected in accordance with Articles 17,18,19 and 20 of the Financial Administration Proclamation No.17/1997 and Article 17 of the Oromia Regional State Financial Administration Regulations No. 8/1998.

4. Budget Execution

- 1. The head of the Oromia Finance Bureau is hereby authorized, upon the request of the heads of the concerned Oromia Regional State organs, to disburse out of the public revenue of the Region and other fund the amounts appropriated for the programmes of their respective departments.
- 2. The Head of the Oromia Finance Bureau is hereby authorized to grant permission to the Oromia Regional State Hospitals, to retain and expend with their total budgetary appropriation of the current fiscal year and amount not exceeding 50% (fifty per cent) of their previous fiscal year receipts.
